### **COURSE DESCRIPTION:**

#### WHAT TO BRING TO THE COURSE:

Casual attire is suitable. Camera: digital, 8MB or larger, detachable flash with minimum 6 foot cord, lens (minimum 55mm), shutter release cord or self-timer, and tripod, scales (mm), and at least 300 mm in length, Tape measure: Steel, at least 50 feet in length, and SD media cards.

#### WHO SHOULD ATTEND?
