## COURSE DESCRIPTION:



Crime Scene Photography is much more than a "point and shoot" exercise. The thorough and professional documentation of crime scenes and evidence is an important skill to master. Our photography course will begin with how the camera works, the different exposure modes, and how light is evaluated in order to record a quality image. The lessons will then move towards composition and documenting crime scenes with the camera.
