### BASIC FINGERPRINT COMPARISON AND INTERPRETATION

### **COURSE DESCRIPTION:**

This course serves as an introductory 40-hour session to fingerprints which includes but is not limited to lectures and practical exercises. The target audience will be those with little to no experience in fingerprint comparison for both ten print and latent print examiners. Subjects in this course include the history of friction ridge comparison, fingerprint pattern interpretation and classification, lecture and practical exercises, friction ridge structure and development, basic comparison techniques, latent print development and latent evaluation, comparison documentation, obtaining known standards of fingers and palms, and courtroom testimony basics. This course may also be an excellent review for those preparing for the Ten Print Certification test.





### **COURSE TOPICS:**

- Historical perspectives of friction skin
- Foundation of friction skin as a means of identification
- Skin structure
- Pattern interpretation
- Obtaining known standards foundations
- Current fingerprint terminology analysis of suitability for comparisons.
- Red flag indicators
- Note taking, report writing
- Courtroom testimony basics
- AFIS and digital comparisons.

### WHAT TO BRING TO CLASS:

Casual attire is suitable. Students will be required to bring their magnifying glasses and pointers.

A personal laptop computer is recommended but not required.

This is a combination class with both lectures and hands on activities specifically designed for entry level ten print and latent print examiners. It will befit anyone who has an interest in friction skin comparison, including those who need to brush up on their skills.
